

### Supervision File - Hospital Outpatient Therapeutic Services

The following table lists the hospital outpatient therapeutic services that, as of the listed effective dates, are either designated as non-surgical extended duration therapeutic services (NSEDTS or “extended duration services”) or may be furnished under general supervision in accordance with applicable Medicare regulations and policies. All other hospital outpatient therapeutic services require a minimum of direct supervision. The definitions of the supervision levels and other supervision requirements are delineated in 42 CFR 410.27 and the Medicare Benefit Policy Manual (Pub. 100-02) Chapter 6, Sections 20.5 - 20.7. For new code(s), we list the effective date for the predecessor code(s).
